From the First Vice Chair CHILDREN AT MEETINGS

Intergroup recently received a complaint from a member about an apparently out of control child at a local meeting questioning why Intergroup didn't impose restrictions on such things. While the member clearly misunderstood the relationship between Intergroup and the meetings/groups in the county, some important questions were raised.

Tradition Four guarantees all AA entities full functional autonomy. We work together in the spirit of Tradition Five which suggests we work to stay sober and to carry the message to the still suffering drunk. That relationship is one of voluntary cooperation, not governance. It means each AA group is responsible for itself making its own decisions for better or worse. Intergroup has no authority to impose anything at the meeting/group level although it can decline to list meetings/groups which fail to honor AA's Traditions.

Any individual seeking recovery from alcoholism should be able to find a place in AA (Tradition Three). That having been said, we understand that in practice some of us have greater difficulty finding that place than others. Some may have additional "grave emotional and mental disorders," some may find the physical act of getting to a meeting challenging while some experience other unusual barriers.

Parents with young children may experience an unusual barrier when they find they have no choice but to

bring their child along to a meeting. Some meetings are quite "child friendly," usual attendees have little or no problem with one or more or many perhaps very active children in the meetings. Other meetings are quite intolerant of any disruption.

Our Traditions suggest every AA group owes it to the individual seeking recovery from drinking to make their meeting in every way accessible. At the same time, Tradition One ("common welfare comes first") suggests the group has an obligation to avoid disruptive or divisive influences so our message can be delivered.

To me, all of this means our meetings/groups should be supportive, patient and tolerant of the special needs of all who come to us remembering "but for the Grace of God." At the same time, the parent of a child in this case should do all they can to monitor their child while at a meeting to minimize any disruption the child may present. Some parents bring toys or games to help engage the child, or will walk a disruptive child out for a few minutes. Some groups and individual members are prepared to help the parents of young children with some respite support during a meeting understanding that doing so imposes unusual responsibilities on the non-parent care giver.

This does not begin to consider the other question that comes up with children at meetings: When does a child become old enough for us to question are they oblivious to or will they hold in confidence who and what they see and hear in meetings?

Hope this is helpful.
